Welcome:

1. RX Drop Kiosks

- a. LBPD (Rosanne)
- b. **Shoalwater (Leslie)** - still waiting on approval from the Tribe to have it here and where to put it. Current one does not comply because it is outside, which MediProject requires it be inside. Chief is waiting to hear back about getting it put in the medical center.

Additional Kiosks - Ilwaco Fire Station

2. Safe Storage Campaign

- a. **Social Media Campaign** - TAC, R2R and WellSpring are working on a 4-week social media campaign for opioid prevention.
- b. Additional campaign ideas for the future:
 - i. **Marijuana prevention campaign** - parent education, DUI, media toolkits through YMPEP. New projects happening in July - one of which is a harm reduction and prevention presentation.
 - ii. Nicotine overdoses on the rise for youth. Incorporate vape product in the above campaigns. Note: we don't know what youth are vaping. Youth overdosing from the liquid used in vape products absorbing in their skin, etc. Note: we do not know what is in the liquid used for the vape products (heroin, Red Bull, nicotine, etc). Get information out about packaging and keeping these products away from youth. Nicotine would be on the outside of the packages, not only on the inside of the containers. *Ensure people understand these things when they fill up the containers - lock up your products.*
 - iii. Timeline: after July 2021. Table until the June 2021 SUP meeting.
 - iv. Good information for first time parents. No shame!
 - v. CPWI Survey shows decrease in perception of harm driving under the influence of alcohol and marijuana
- c. Foster parents / families
 - i. WA State
 - ii. SPIPA (Tribal) South Puget Intertribal Planning Agency - TANF will support children staying in the home. They do get families doing kinship care and

temporary placement. WA state law has changed - they are doing away with third party (kinship) care. Unsure how this will work with foster care and tribal TANF. TANF will move to a 477 plan - assisting with WIOA. Bethany has been working with SPIPA. Josh Jewell for WA state - 12 foster families. He will be reaching out to them to inquire about how many need locking bags - max # bags will be 12.

- d. **Targeted Groups** - using 50 / 70 bags split between two WBH locations and WISE team to ensure they have access to them to ensure anyone receiving medication will have a lock bag.
- e. CPAA & YMPEP purchased bags can be distributed any end of the County. CPAA bags will be available at the Opioid Summit sites.
- f. **Pharmacies** - Denise already has been working with South Bend Pharmacy. Peninsula Pharmacies are doing a lot of COVID response work and may not want to add another thing to their plate. Having them fill out the forms may be too much to handle at this time. However, giving them the QR code and encouraging them to get one if they have youth in the home.
- g. Information (QR code) and working with the dispensaries.
 - i. Follow up with Denise re: QR code for dispensaries and Shoalwater.

TO DO: get Kayla link for medication lock bags.

4. Supplies - Bethany has sandwich boards for South Bend's event.
